

OFFICE ORDER

In pursuance of UGC (Prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions) Regulations, 2015 read with sexual harassment of women at workplace (prevention, prohibition and redressal) Act, 2073, the Women Cell is constituted at Vivekananda Global University including two committees as under:

1. Internal Complaints Committee (ICC) is constituted to monitor all cases related to sexual harassment at various places of the campus (Ref. Notice-1522 dated 2.12.2025). The ICC work towards prevention and grievance redressal and look into all complaints of sexual harassment filed by the women students and women staff members and adhere to all the rules and regulations.
